- 2.6 The Second Party will actively engage to help the delivery of the training and placement of students of the First Party into internships/jobs.

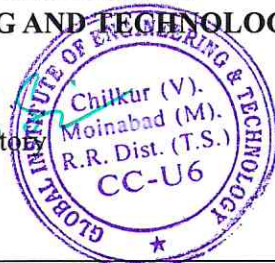
III. VALIDITY

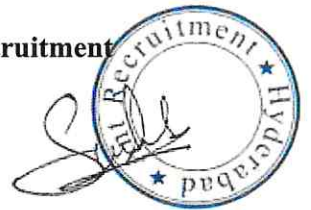
