The University conducted meetings of the Standing Committee of the Academic Senate on 10.09.2015, 24.09.2015 and 27.10.2015, and took certain major decisions pertaining to Academic Regulations and Course Structure for the benefit of the Students of the University. The Principals of the Constituent and Affiliated Colleges and Directors of all the Units are requested to communicate these decisions to the students in their units as detailed below:

- ➤ To conduct awareness program on R15 UG Academic Regulations and procedures, in particular, the Promotion Policy and display the contents on all the Notice Boards/Websites of the Colleges and Units since the decisions have to be implement from the First year class itself admitted from the academic year 2015-16.
- Every student must have a copy of the Academic Regulations, Course Structure and syllabi to know the regulations and procedures. This is mandatory and most important. So the Principals are requested to procure the syllabus books from the University on priority basis.

- Relaxation of credits from R07 batch to R13 batch for promotion from Second year to Third year and Third year to Fourth year B.Tech./B. Pharm. Programs as given in the previous year cannot be continued further since the students have to complete their course within the stipulated 8 years. This is the last chance for all the batches for making use of the relaxation of credits for promotion to the next class.
- ➤ Amendment of R13 and R 15 Regulations of 7.3 and 7.4 of B.Tech./B.Pharmacy programs for promotion rules.
- ➤ Amended the R13 and R 15 Regulations under Point No. 8 Course pattern of B.Tech./B. Pharmacy programs.
- Modified Academic Calendar for conducting supplementary examinations for odd semesters in the month of February/March and Even semester in the month of August/September.
- Provision of conducting one Computer based Test (CBT) for Internal marks for the students on rolls transferred from other Universities/Institutions to JNTUH Affiliated Colleges in failed subjects and/or subjects not studied, as per the clearance and equivalence letter issued by the University.
- Provision of one chance to write Internal examinations in the failed subjects and/or subjects not studied to the students transferred from other Universities/Institutions to JNTUH Autonomous Affiliated Colleges who are on rolls, as per the clearance and equivalence letter issued by the University.
- Introduction of the study content as prescribed by NASSCOM in collaboration with TASK for job roles, such as Associate Analyst or Security Analyst, the study content is an additional elective in III Year II Semester, IV year I Semester and II Semester in B.Tech. Computer Science & Engineering and Information Technology. The students have to take a series of electives in the next semesters also as per the Revised Course Structure. The pattern of Internal and External Exams is as per the Regulations. The interested students who have taken the above subjects as electives, have to appear for the online exam to be conducted by NAASCOM separately after IV Year II Semester for the purpose of certification issued by NASSCOM. Teacher module and Student module content will be provided by the NAASCOM.
- Introduction of the 'Gender Sensitization' as a new course and it is a compulsory subject in the academic year 2015-16 in II Year II semester of B.Tech. and B. Pharmacy of all the branches in the Constituent and Affiliated Colleges of JNTUH including Autonomous Colleges without any change in the existing course structure of R 13 and R15 Regulations. This subject should be treated as a Student centered Lab subject with two credits. The examination in this course will be conducted as per the regulations. The Text Book for this course is "Towards a World of Equals: A Bilingual Text Book on Gender".

In view of the above modifications, the Principals of the Constituent Colleges and Directors of the Units and Principals of the Affiliated College are requested to make every student aware of the modifications made by the University.

REVISED ACADEMIC REGULATIONS R13 FOR B. TECH. (REGULAR)

Applicable for the students of B. Tech. (Regular) from the Academic Year 2013-14 and onwards

1. Award of B. Tech. Degree

A student will be declared eligible for the award of B. Tech. Degree if he fulfils the following academic regulations:

- 1.1 The candidate shall pursue a course of study for not less than four academic years and not more than eight academic years.
- 1.2 After eight academic years of course of study, the candidate is permitted to write the examinations for two more years.
- 1.3 The candidate shall register for 224 credits and secure 216 credits. The student can avail exemption of two subjects upto 8 credits, that is, one open elective and one elective subject or two elective subjects under regular stream, with compulsory subjects listed in the Table 1.

The students, who fail to fulfill all the academic requirements for the award of the degree within ten academic years from the year of their admission, shall forfeit their seats in B. Tech. course.

5 Distribution and Weightage of Marks

- 5.1 The performance of a student in each semester or I year shall be evaluated subject-wise for a maximum of 100 marks for a theory and 75 marks for a practical subject. In addition, industry-oriented mini-project, seminar and project work shall be evaluated for 50, 50 and 200 marks, respectively.
- 5.2 For theory subjects the distribution shall be 25 marks for Internal Evaluation and 75 marks for the End-Examination.
- For theory subjects, during a semester there shall be 2 mid-term examinations. Each mid-term examination consists of one objective paper, one essay paper and one assignment. The objective paper and the essay paper shall be for 10 marks each with a total duration of 1 hour 20 minutes (20 minutes for objective and 60 minutes for essay paper). The Objective paper is set with 20 bits of multiple choice, fillin the blanks and matching type of questions for a total of 10 marks. The essay paper shall contain 4 full questions (one from each unit) out of which, the student has to answer 2 questions, each carrying 5 marks. While the first mid-term examination shall be conducted on 1 to 2.5 units of the syllabus, the second mid-term examination shall be conducted on 2.5 to 5 units. Five (5) marks are allocated for Assignments (as specified by the subject teacher concerned). The first Assignment should be submitted before the conduct of the first mid-examination, and the second Assignment should be submitted before the conduct of the second mid-examination. The total marks secured by the student in each mid-term examination are evaluated for 25 marks, and the average of the two mid-term examinations shall be taken as the final marks secured by each candidate. However, in the I year, there shall be 3 mid term examinations, each for 25 marks, along with 3 assignments in a similar pattern as above (1st mid shall be from Unit-I, 2nd mid shall be 2 &3 Units and 3rd mid shall be 4 & 5 Units) and the average marks of the examinations secured (each evaluated for a total of 25 marks) in each subject shall be considered to be final marks for the internals/sessionals. If any candidate is absent from any subject of a mid-term examination, an on-line test will be conducted for him by the University.

The details of the Question Paper pattern without deviating from the R13 regulations as notified in the website is as follows:

- The End semesters Examination will be conducted for 75 marks which consists of two parts viz. i). Part-A for 25 marks, ii). Part -B for 50 marks.
- Part-A is compulsory question which consists of ten sub-questions. The first five subquestions are from each unit and carries 2 marks each. The next five sub-questions are one from each unit and carries 3 marks each.
- Part-B consists of five Questions (numbered from 2 to 6) carrying 10 marks each. Each of these questions is from one unit and may contain sub-questions. For each question there will be an "either" "or" choice (that means there will be two questions from each unit and the student should answer any one question)
- 5.4 For practical subjects there shall be a continuous evaluation during a semester for 25 sessional marks and 50 end semester examination marks. Out of the 25 marks for internal evaluation, day-to-day work in the laboratory shall be evaluated for 15 marks and internal practical examination shall be evaluated for 10 marks conducted by the laboratory teacher concerned. The end semester examination shall be conducted with an external examiner and the laboratory teacher. The external examiner shall be appointed from the clusters of colleges which are decided by the examination branch of the University.
- 5.5 For the subject having design and/or drawing, (such as Engineering Graphics, Engineering Drawing, Machine Drawing) and Estimation, the distribution shall be 25 marks for internal evaluation (15 marks for day-to-day work and 10 marks for internal tests) and 75 marks for end semester examination. There shall be two internal tests in a Semester and the average of the two shall be considered for the award of marks for internal tests. However, in the I year class, there shall be three tests and the average will be taken into consideration.

- 5.6 There shall be an industry-oriented Mini-Project, in collaboration with an industry of their specialization, to be taken up during the vacation after III year II Semester examination. However, the mini-project and its report shall be evaluated along with the project work in IV year II Semester. The industry oriented mini-project shall be submitted in a report form and presented before the committee. It shall be evaluated for 50 marks. The committee consists of an external examiner, head of the department, the supervisor of the mini-project and a senior faculty member of the department. There shall be no internal marks for industry-oriented mini-project.
- 5.7 There shall be a seminar presentation in IV year II Semester. For the seminar, the student shall collect the information on a specialized topic and prepare a technical report, showing his understanding of the topic, and submit it to the department. It shall be evaluated by the departmental committee consisting of head of the department, seminar supervisor and a senior faculty member. The seminar report shall be evaluated for 50 marks. There shall be no external examination for the seminar.
- 5.8 There shall be a Comprehensive Viva-Voce in IV year II semester. The Comprehensive Viva-Voce will be conducted by a Committee consisting of Head of the Department and two Senior Faculty members of the Department. The Comprehensive Viva-Voce is intended to assess the student's understanding of the subjects he studied during the B. Tech. course of study. The Comprehensive Viva-Voce is evaluated for 100 marks by the Committee. There are no internal marks for the Comprehensive Viva-Voce.
- Out of a total of 200 marks for the project work, 50 marks shall be allotted for Internal Evaluation and 150 marks for the End Semester Examination (Viva Voce). The End Semester Examination of the project work shall be conducted by the same committee as appointed for the industry-oriented mini-project. In addition, the project supervisor shall also be included in the committee. The topics for industry oriented mini project, seminar and project work shall be different from one another. The evaluation of project work shall be made at the end of the IV year. The Internal Evaluation shall be on the basis of two seminars given by each student on the topic of his project.
- 5.10 The Laboratory marks and the sessional marks awarded by the College are subject to scrutiny and scaling by the University wherever necessary. In such cases, the sessional and laboratory marks awarded by the College will be referred to a Committee. The Committee will arrive at a scaling factor and the marks will be scaled accordingly. The recommendations of the Committee are final and binding. The laboratory records and internal test papers shall be preserved in the respective institutions as per the University rules and produced before the Committees of the University as and when asked for.

6 Attendance Requirements

- 6.1 A student is eligible to write the University examinations only if he acquires a minimum of 75% of attendance in aggregate of all the subjects.
- 6.2 Condonation of shortage of attendance in aggregate up to 10% (65% and above and below 75%) in each semester or I year may be granted by the College Academic Committee
- 6.3 Shortage of Attendance below 65% in aggregate shall not be condoned.
- 6.4 A student who is short of attendance in semester / I year may seek re-admission into that semester/l year when offered within 4 weeks from the date of the commencement of class work.
- 6.5 Students whose shortage of attendance is not condoned in any semester/I year are not eligible to write their end semester examination of that class and their registration stands cancelled.
- 6.6 A stipulated fee shall be payable towards condonation of shortage of attendance.
- 6.7 A student will be promoted to the next semester if he satisfies the attendance requirement of the present semester/l year, as applicable, including the days of attendance in sports, games, NCC and NSS activities.
- 6.8 If any candidate fulfills the attendance requirement in the present semester or I year, he shall not be eligible for readmission into the same class.

7 Minimum Academic Requirements

The following academic requirements have to be satisfied in addition to the attendance requirements mentioned in item no.6.

- 7.1 A student is deemed to have satisfied the minimum academic requirements if he has earned the credits allotted to each theory/practical design/drawing subject/project and secures not less than 35% of marks in the end semester exam, and minimum 40% of marks in the sum total of the mid-term and end semester exams.
- 7.2 A student shall be promoted from first year to second year if he fulfills the minimum attendance requirement.
- 7.3 A student shall be promoted from Second year to Third year only if he fulfills the academic requirement of 34 credits from one regular and one supplementary examinations of I year, and one regular and one supplementary examination of II year I semester irrespective of whether or

not the candidate takes the examination and secures prescribed minimum attendance in II Year II Semester.

- 7.4 A student shall be promoted from third year to fourth year only if he fulfils the academic requirements of total 56 credits from the following examinations, whether the candidate takes the examinations or not, and secures prescribed minimum attendance in III Year II Semester:
 - a. Two regular and two supplementary examinations of I year.
 - b. Two regular and two supplementary examinations of II year I semester.
 - c. Two regular and one supplementary examinations of II year II semester.
 - d. One regular and one supplementation examination of III year I semester.
- 7.5 A student shall register and put up minimum attendance in all 224 credits and earn 216 credits. Marks obtained in the best 216 credits shall be considered for the calculation of percentage of marks.
- 7.6 Students who fail to earn 216 credits as indicated in the course structure within ten academic years (8 years of study + 2 years additionally for appearing for exams only) from the year of their admission, shall forfeit their seat in B.Tech. course and their admission stands cancelled.

8 Course pattern

- 8.1 The entire course of study is for four academic years. I year shall be on yearly pattern and II, III and IV years on semester pattern.
- 8.2 A student, eligible to appear for the end examination in a subject, but absent from it or has failed in the end semester examination, may write the exam in that subject during the period of supplementary exams
- 8.3 When a student is detained in a semester/year due to shortage of attendance, he may be readmitted when the same semester/year is offered for the next academic year for fulfillment of academic requirements. However, the academic regulations under which he was first admitted, shall continues to be applicable to him.
- 8.4 When a student is detained due to lack of credits, he may be promoted to the next academic year only after acquiring the required academic credits. However, the academic regulations under which he was first admitted, shall continues to be applicable to him.

9 Award of Class

After a student has satisfied the requirements prescribed for the completion of the program and is eligible for the award of B. Tech. Degree, he shall be placed in one of the following four classes:

The marks obtained in internal evaluation and end semester / I year examination shall be shown separately in the memorandum of marks.

10 Minimum Instruction Days

The minimum instruction days for each semester/I year shall be 90/180 days.

- There shall be no branch transfers after the completion of the admission process.
- There shall be no transfer from one college/stream to another within the Constituent Colleges and Units of Jawaharlal Nehru Technological University Hyderabad.

13 WITHHOLDING OF RESULTS

If the student has not paid the dues, if any, to the university or if any case of indiscipline is pending against him, the result of the student will be withheld and he will not be allowed into the next semester. His degree will be withheld in such cases.

14. TRANSITORY REGULATIONS

- 14.2 After the revision of the regulations, the students of the previous batches will be given two chances for passing in their failed subjects, one supplementary and the other regular. If the students cannot clear the subjects in the given two chances, they shall be given equivalent subjects as per the revised regulations which they have to pass in order to obtain the required number of credits.
- 14.3 In case of transferred students from other Universities, the credits shall be transferred to JNTUH as per the academic regulations and course structure of the JNTUH.

15. General

- 15.1 Wherever the words "he", "him", "his", occur in the regulations, they include "she", "her", "hers".
- 15.2 The academic regulation should be read as a whole for the purpose of any interpretation.
- 15.3 In case of any doubt or ambiguity in the interpretation of the above rules, the decision of the Vice-Chancellor is final.
- 15.4 The University may change or amend the academic regulations or syllabi at any time and the changes or amendments made shall be applicable to all the students with effect from the dates notified by the University.
- The students seeking transfer to colleges affiliated to JNTUH from various other Universities/Institutions, have to pass the failed subjects which are equivalent to the subjects of JNTUH, and also pass the subjects of JNTUH which the candidates have not studied at the earlier Institution on their own without the right to sessional marks. Further, though the students have passed some of the subjects at the earlier institutions, if the same subjects are prescribed in different semesters of JNTUH, the candidates have to study those subjects in JNTUH in spite of the fact that those subjects are repeated.

REVISED ACADEMIC REGULATIONS R13 FOR B. TECH. (LATERAL ENTRY SCHEME)

Applicable for the students admitted into II year B. Tech. (LES) from the Academic Year 2013-14 and onwards

1 Eligibility for award of B. Tech. Degree (LES)

- The LES candidates shall pursue a course of study for not less than three academic years and not more than six academic years.
- II. They shall be permitted to write the examinations for two more years after six academic years of course work.
- The candidate shall register for 168 credits and secure 160 credits from II to IV year B.Tech. Program (LES) for the award of B.Tech. degree.. The student can avail exemption of two subjects upto 8 credits, that is, one open elective and one elective subject or two elective subjects under regular stream, with compulsory subjects listed in the Table 1.

- 3. The students, who fail to fulfil the requirement for the award of the degree in 8 consecutive academic years (6 years of study + 2 years additionally for appearing exams only) from the year of admission, shall forfeit their seats.
- 4. The attendance regulations of B. Tech. (Regular) shall be applicable to B.Tech. (LES).

5. Promotion Rule

A student shall be promoted from second year to third year if he fulfills the minimum attendance requirement.

A student shall be promoted from III year to IV year only if he fulfils the academic requirements of total 34 credits from the following examinations, whether the candidate takes the examinations or not, and secures prescribed minimum attendance in III Year II Semester:

- a) Two regular and Two supplementary examinations of II year I semester.
- b) Two regular and one supplementary examinations of II year II semester.
- c) One regular and one supplementary examination of III year I semester.

6. Award of Class

After a student has satisfied the requirement prescribed for the completion of the program and is eligible for the award of B. Tech. Degree, he shall be placed in one of the following four classes:

REVISED ACADEMIC REGULATIONS R13 FOR B. PHARM. (REGULAR)

Applicable for the students of B. Pharm. (Regular) from the Academic Year 2013-14and onwards.

1. Award of B. Pharm, Degree

A student will be declared eligible for award of the B. Pharm. Degree if he fulfils the following academic regulations:

- 1.1 The candidate shall pursue a course of study for not less than four academic years and not more than eight academic years.
- 1.2 After eight academic years of course work, the candidate is permitted to write the examinations for two more years.
- 1.3 The candidate shall register for all the prescribed 224 credits and secure all the 224 credits.
- The students, who fail to fulfil all the academic requirements for the award of the degree within ten academic
 years from the year of their admission, shall forfeit their seats in B. Pharm. course.

4. Distribution and Weightage of Marks

- 4.1 The performance of a student in each semester or I year shall be evaluated subject-wise for a maximum of 100 marks for a theory and 75 marks for a practical subject. In addition, Seminar and Project Work shall be evaluated for 50 and 100 marks, respectively.
- 4.2 For theory subjects the distribution shall be 25 marks for Internal Evaluation and 75 marks for the End-Examination.
- 4.3 For theory subjects, during a semester there shall be 2 mid-term examinations. Each mid-term examination consists of one objective paper, one essay paper and one assignment. The objective paper and essay paper shall be for 10 marks each with a total duration of 1 hour 20 minutes (20 minutes for objective and 60 minutes for essay paper). The Objective paper is set with 20 bits of multiple choice, fill-in the blanks and matching type of questions for a total of 10 marks.

The essay paper shall contain 4 full questions (one from each unit) out of which, the student has to answer 2 questions, each carrying 5 marks.

While the first mid-term examination shall be conducted on 1 to 2.5 units of the syllabus, the second mid-term examination shall be conducted on 2.5 to 5 units. 5 marks are allocated for Assignments as specified by the subject teacher concerned to the first Assignment should be submitted before the conduct of the first mid-examination, and the second Assignment should be submitted before the conduct of the second mid-examination. The total marks secured by the student in each mid-term examination are evaluated for 25 marks, and the average of the two mid-term examinations shall be taken as the final marks secured by each candidate.

However, in the I year, there shall be 3 mid term examinations (each for 25 marks), along with 3 assignments in a similar pattern as above (1st mid shall be from Unit-I, 2nd mid shall be 2 &3 Units and 3rd mid shall be 4 & 5 Units) and the average marks of the examinations secured (each evaluated for a total of 25 marks) in each subject shall be considered as final marks for the internals/sessionals. If any candidate is absent from any subject of a mid-term examination, an on-line test will be conducted

for him by the university. The details of the Question Paper pattern without deviating from the R13 regulations as notified in the website is as follows:

- The End semesters Examination will be conducted for 75 marks which consists of two parts viz. i). Part-A for 25 marks, ii). Part -B for 50 marks.
- Part-A is compulsory question which consists of ten sub-questions. The first five subquestions are from each unit and carries 2 marks each. The next five sub-questions are one from each unit and carries 3 marks each.
- Part-B consists of five Questions (numbered from 2 to 6) carrying 10 marks each. Each of these questions is from one unit and may contain sub-questions. For each question there will be an "either" "or" choice (that means there will be two questions from each unit and the student should answer any one question)
- For practical subjects there shall be a continuous evaluation during a semester for 25 sessional marks and 50 end semester examination marks. Out of the 25 marks for internal evaluation, day-to-day work in the laboratory shall be evaluated for 15 marks and internal examination for practical shall be evaluated for 10 marks conducted by the laboratory teacher concerned. The end semester examination shall be conducted with an external examiner and the laboratory teacher. The external examiner shall be appointed from the clusters of colleges which are decided by the examination branch of the University.
- There shall be a seminar presentation in IV Year I Semester. For the seminar, the student shall collect the information on a specialized topic and prepare a technical report, showing his understanding of the topic, and submit it to the department. It shall be evaluated by the Departmental Academic Committee consisting of Head of the Department, Seminar Supervisor and a Senior Faculty Member. The seminar report shall be evaluated for 50 marks. There shall be no external examination for the seminar.
- Out of a total of 100 marks for the project work, 25 marks shall be allotted for Internal Evaluation and 75 marks for the End Semester Examination (Viva Voce). The End Semester Examination shall be conducted by a committee consisting of an external examiner, head of the department, supervisor of the project and a senior faculty member of the department. Seminar and project work shall be on the same topic. The evaluation of project work shall be conducted at the end of the IV year. The Internal Evaluation shall be on the basis of two seminars given by each student on the topic of his project.
- 4.7 The Laboratory marks and the sessional marks awarded by the College are subject to scrutiny and scaling by the University wherever necessary. In such cases, the sessional and laboratory marks awarded by the College will be referred to a Committee. The Committee will arrive at a scaling factor and the marks will be scaled as per the scaling factor. The recommendations of the Committee are final and binding. The laboratory records and internal test papers shall be preserved in the respective institutions as per the University norms and produced to the Committees of the University as and when required.
- There shall be a Comprehensive Viva-Voce in IV year II semester. The Comprehensive Viva-Voce will be conducted by a Committee consisting of the Head of the Department and two Senior Faculty members of the Department. The Comprehensive Viva-Voce is intended to assess the students' understanding of the subjects that he studied during the B. Pharm. course of study. The Comprehensive Viva-Voce is valued for 100 marks by the Committee. There are no internal marks for the Comprehensive Viva-Voce.

5. Attendance

- 5.1 A student is eligible to write the University examinations only if he acquires a minimum of 75% of attendance in aggregate of all the subjects.
- 5.2 Condonation of shortage of attendance in aggregate up to 10% (65% and above and below 75%) in each semester or I year may be granted by the College Academic Committee.
- 5.3 Shortage of Attendance below 65% in aggregate shall not be condoned.
- 5.4 A student who is short of attendance in a semester / I year may seek re-admission into that semester/I year when offered within 4 weeks from the date of the commencement of class work.
- 5.5 Students whose shortage of attendance is not condoned in any semester/I year, are not eligible to write their end semester examinations of that class and their registration stands cancelled.
- 5.6 A stipulated fee shall be payable towards condonation of shortage of attendance.
- 5.7 A student will be promoted to the next semester if he satisfies the attendance requirement of the present semester/l year, as applicable, including the days of attendance in sports, games, NCC and NSS activities...
- 5.8 If any candidate fulfils the attendance requirement in the present semester or I year, he shall not be eligible for readmission into the same class.

6. Minimum Academic Requirements

The following academic requirements have to be satisfied in addition to the attendance requirements mentioned in item no. 5.

- 6.1 A student is deemed to have satisfied the minimum academic requirements if he has earned the credits allotted to each theory/practical design/drawing subject/project and secures not less than 35% of marks in the end semester exam, and minimum 40% of marks in the sum total of the midterm and end semester exams.
- 6.2 A student shall be promoted from first year to second year if he fulfills the minimum attendance requirement.
- 6.3 A student shall be promoted from Second year to Third year only if he fulfills the academic requirement of 34 credits from one regular and one supplementary examinations of I year, and one regular and one supplementary examination of II year I semester irrespective of whether or not the candidate takes the examination and secures prescribed minimum attendance in II Year II Semester.
- 6.4 A student shall be promoted from third year to fourth year only if he fulfils the academic requirements of total 56 credits from the following examinations, whether the candidate takes the examinations or not, and secures prescribed minimum attendance in III Year II Semester:
 - a. Two regular and two supplementary examinations of I year.
 - b. Two regular and two supplementary examinations of II year I semester.
 - c. Two regular and one supplementary examinations of II year II semester.
 - d. One regular and one supplementation examination of III year I semester.
- 6.5 Students who fail to earn 224 credits as indicated in the course structure within ten academic years from the year of their admission shall forfeit their seats in B. Pharm. course and their admission stands cancelled.

7 Course pattern

- 7.1 The entire course of study is for four academic years. I year shall be on yearly pattern and II, III and IV years on semester pattern.
- 7.2 A student, eligible to appear for the end examination in a subject, but absent from it or has failed in the end semester examination, may write the exam in that subject during the period of supplementary exams.
- 7.3 When a student is detained in a semester/year due to shortage of attendance, he may be readmitted when the same semester/year is offered for the next academic year for fulfillment of academic requirements. However, the academic regulations under which he was first admitted, shall continues to be applicable to him.
- 7.4 When a student is detained due to lack of credits, he may be promoted to the next academic year only after acquiring the required academic credits. However, the academic regulations under which he was first admitted, shall continues to be applicable to him.

8 Award of Class

After a student has satisfied the requirements prescribed for the completion of the program and is eligible for the award of B. Pharm. Degree, he shall be placed in one of the following four classes:

9 Minimum Instruction Days

The minimum instruction days for each semester/I year shall be 90/180 days.

- 10. There shall be no branch transfers after the completion of the admission process.
- 11. There shall be no transfer from one college/stream to another within the Constituent Colleges and Units of Jawaharlal Nehru Technological University Hyderabad.

12. WITHHOLDING OF RESULTS

If the student has not paid the dues, if any, to the university or if any case of indiscipline is pending against him, the result of the student will be withheld and he will not be allowed into the next semester. His degree will be withheld in such cases.

13. TRANSITORY REGULATIONS

- 13.1 Discontinued, detained, or failed candidates are eligible for re-admission to two earlier or equivalent subjects at a time as and when offered.
- 13.2 The candidate who fails in any subject will be given two chances to pass the same subject; otherwise, he has to identify an equivalent subject as per R13 academic regulations.
- 13.3 After the revision of the regulations, the students of the previous batches will be given two chances for passing in their failed subjects, one supplementary and the other regular. If the students cannot clear the subjects in the given two chances, they shall be given equivalent subjects as per the revised regulations which they have to clear in order to obtain the required number of credits.
- 13.4 In case of transferred students from other Universities, the credits shall be transferred to JNTUH as per the academic regulations and course structure of the University.

14. General

- 14.1 Wherever the words "he", "him", "his", occur in the regulations, they include "she", "her", "hers".
- 14.2 The academic regulations should be read as a whole for purpose of any interpretation.
- 14.3 In case of any doubt or ambiguity in the interpretation of the above rules, the decision of the Vice-
- 14.4 The University may change or amend the academic regulations and syllabi at any time and the changes and amendments made shall be applicable to all the students of all classes with effect from the date notified by the University.
- 14.5 There shall be no transfers of students from one constituent college to another constituent college of Jawaharlal Nehru Technological University Hyderabad.
- The students seeking transfer to colleges affiliated to JNTUH from various other Universities/Institutions have to pass the failed subjects which are equivalent to the subjects of JNTUH, and also pass the subjects of JNTUH which the candidates have not studied at the earlier Institution, on their own without the right to sessional marks. Further, though the students have passed some of the subjects at the earlier institutions, if the same subjects are prescribed in different semesters of JNTUH, the candidates have to study those subjects in JNTUH in spite of the fact that those subjects are repeated.

5 <u>Distribution and Weightage of Marks</u>

- 5.1 The performance of a student in each semester or I year shall be evaluated subject-wise for a maximum of 100 marks for a theory and 75 marks for a practical subject. In addition, industry-oriented mini-project, seminar and project work shall be evaluated for 50, 50 and 200 marks, respectively.
- 5.2 For theory subjects the distribution shall be 25 marks for Internal Evaluation and 75 marks for the End-Examination.
- For theory subjects, during a semester there shall be 2 mid-term examinations. Each mid-term examination consists of one objective paper, one essay paper and one assignment. The objective paper and the essay paper shall be for 10 marks each with a total duration of 1 hour 20 minutes (20 minutes for objective and 60 minutes for essay paper). The Objective paper is set with 20 bits of multiple choice, fillin the blanks and matching type of questions for a total of 10 marks. The essay paper shall contain 4 full questions (one from each unit) out of which, the student has to answer 2 questions, each carrying 5 marks. While the first mid-term examination shall be conducted on 1 to 2.5 units of the syllabus, the second mid-term examination shall be conducted on 2.5 to 5 units. Five (5) marks are allocated for Assignments (as specified by the subject teacher concerned). The first Assignment should be submitted before the conduct of the first mid-examination, and the second Assignment should be submitted before the conduct of the second mid-examination. The total marks secured by the student in each mid-term examination are evaluated for 25 marks, and the average of the two mid-term examinations shall be taken as the final marks secured by each candidate. However, in the I year, there shall be 3 mid term examinations, each for 25 marks, along with 3 assignments in a similar pattern as above (1st mid shall be from Unit-I, 2nd mid shall be 2 &3 Units and 3rd mid shall be 4 & 5 Units) and the average marks of the examinations secured (each evaluated for a total of 25 marks) in each subject shall be considered to be final marks for the internals/sessionals. If any candidate is absent from any subject of a mid-term examination, an on-line test will be conducted for him by the University.

The details of the Question Paper pattern is as follows:

- The End semesters Examination will be conducted for 75 marks which consists of two parts viz. i).
 Part-A for 25 marks, ii). Part -B for 50 marks.
- Part-A is compulsory question which consists of ten sub-questions. The first five sub-questions are from each unit and carries 2 marks each. The next five sub-questions are one from each unit and carries 3 marks each.
- Part-B consists of five Questions (numbered from 2 to 6) carrying 10 marks each. Each of these
 questions is from one unit and may contain sub-questions. For each question there will be an
 "either" "or" choice (that means there will be two questions from each unit and the student should
 answer any one question)
- 5.4 For practical subjects there shall be a continuous evaluation during a semester for 25 sessional marks and 50 end semester examination marks. Out of the 25 marks for internal evaluation, day-to-day work in the laboratory shall be evaluated for 15 marks and internal practical examination shall be evaluated for 10 marks conducted by the laboratory teacher concerned. The end semester examination shall be conducted with an external examiner and the laboratory teacher. The external examiner shall be appointed from the clusters of colleges which are decided by the examination branch of the University.
- 5.5 For the subject having design and/or drawing, (such as Engineering Graphics, Engineering Drawing, Machine Drawing) and Estimation, the distribution shall be 25 marks for internal evaluation (15 marks for day-to-day work and 10 marks for internal tests) and 75 marks for end semester examination. There shall be two internal tests in a Semester and the average of the two shall be considered for the award of marks for internal tests. However, in the I year class, there shall be three tests and the average will be taken into consideration.

- 5.6 There shall be an industry-oriented Mini-Project, in collaboration with an industry of their specialization, to be taken up during the vacation after III year II Semester examination. However, the mini-project and its report shall be evaluated along with the project work in IV year II Semester. The industry oriented mini-project shall be submitted in a report form and presented before the committee. It shall be evaluated for 50 marks. The committee consists of an external examiner, head of the department, the supervisor of the mini-project and a senior faculty member of the department. There shall be no internal marks for industry-oriented mini-project.
- 5.7 There shall be a seminar presentation in IV year II Semester. For the seminar, the student shall collect the information on a specialized topic and prepare a technical report, showing his understanding of the topic, and submit it to the department. It shall be evaluated by the departmental committee consisting of head of the department, seminar supervisor and a senior faculty member. The seminar report shall be evaluated for 50 marks. There shall be no external examination for the seminar.
- 5.8 There shall be a Comprehensive Viva-Voce in IV year II semester. The Comprehensive Viva-Voce will be conducted by a Committee consisting of Head of the Department and two Senior Faculty members of the Department. The Comprehensive Viva-Voce is intended to assess the student's understanding of the subjects he studied during the B. Tech. course of study. The Comprehensive Viva-Voce is evaluated for 100 marks by the Committee. There are no internal marks for the Comprehensive Viva-Voce.
- Out of a total of 200 marks for the project work, 50 marks shall be allotted for Internal Evaluation and 150 marks for the End Semester Examination (Viva Voce). The End Semester Examination of the project work shall be conducted by the same committee as appointed for the industry-oriented mini-project. In addition, the project supervisor shall also be included in the committee. The topics for industry oriented mini project, seminar and project work shall be different from one another. The evaluation of project work shall be made at the end of the IV year. The Internal Evaluation shall be on the basis of two seminars given by each student on the topic of his project.
- 5.10 The Laboratory marks and the sessional marks awarded by the College are subject to scrutiny and scaling by the University wherever necessary. In such cases, the sessional and laboratory marks awarded by the College will be referred to a Committee. The Committee will arrive at a scaling factor and the marks will be scaled accordingly. The recommendations of the Committee are final and binding. The laboratory records and internal test papers shall be preserved in the respective institutions as per the University rules and produced before the Committees of the University as and when asked for.

6 Attendance Requirements

- 6.1 A student is eligible to write the University examinations only if he acquires a minimum of 75% of attendance in aggregate of all the subjects.
- 6.2 Condonation of shortage of attendance in aggregate up to 10% (65% and above and below 75%) in each semester or I year may be granted by the College Academic Committee
- 6.3 Shortage of Attendance below 65% in aggregate shall not be condoned.
- 6.4 A student who is short of attendance in semester / I year may seek re-admission into that semester/I year when offered within 4 weeks from the date of the commencement of class work.
- 6.5 Students whose shortage of attendance is not condoned in any semester/t year are not eligible to write their end semester examination of that class and their registration stands cancelled.
- 6.6 A stipulated fee shall be payable towards condonation of shortage of attendance.
- 6.7 A student will be promoted to the next semester if he satisfies the attendance requirement of the present semester/l year, as applicable, including the days of attendance in sports, games, NCC and NSS activities.
- 6.8 If any candidate fulfills the attendance requirement in the present semester or I year, he shall not be eligible for readmission into the same class.

7 Minimum Academic Requirements

The following academic requirements have to be satisfied in addition to the attendance requirements mentioned in item no.6.

- 7.1 A student is deemed to have satisfied the minimum academic requirements if he has earned the credits allotted to each theory/practical design/drawing subject/project and secures not less than 35% of marks in the end semester exam, and minimum 40% of marks in the sum total of the mid-term and end semester exams.
- 7.2 A student will not be promoted from I Year to II Year unless he fulfills the academic requirement of 28 credits out of 56 credits of I year from all the examinations and secures prescribed minimum attendance in I year.

- 7.3 A student shall be promoted from Second Year to Third year only if he fulfills the academic requirement of 50 credits from one regular and one supplementary examinations of I year, and one regular and one supplementary examination of II year I semester irrespective of whether or not the candidate takes the examination, and secures prescribed minimum attendance in II Year II Semester.
- 7.4 A student shall be promoted from third year to fourth year only if he fulfils the academic requirements of total 84 credits from the following examinations, whether the candidate takes the examinations or not, and secures prescribed minimum attendance in III Year II Semester.
 - a. Two regular and two supplementary examinations of I year.
 - b. Two regular and two supplementary examinations of II year I semester.
 - c. Two regular and one supplementary examinations of II year II semester.
 - d. One regular and one supplementation examination of III year I semester.
- 7.5 A student shall register and put up minimum attendance in all 224 credits and earn 216 credits. Marks obtained in the best 216 credits shall be considered for the calculation of percentage of marks.
- 7.6 Students who fail to earn 216 credits as indicated in the course structure within ten academic years (8 years of study + 2 years additionally for appearing for exams only) from the year of their admission, shall forfeit their seat in B.Tech, course and their admission stands cancelled.

8 Course pattern

- 8.1 The entire course of study is for four academic years. I year shall be on yearly pattern and II, III and IV years on semester pattern.
- 8.2 A student, eligible to appear for the end examination in a subject, but absent from it or has failed in the end semester examination, may write the exam in that subject during the period of supplementary exams.
- 8.3 When a student is detained in a semester/year due to shortage of attendance, he may be readmitted when the same semester/year is offered for the next academic year for fulfillment of academic requirements. However, the academic regulations under which he was first admitted, shall continues to be applicable to him.
- 8.4 When a student is detained due to lack of credits, he may be promoted to the next academic year only after acquiring the required academic credits. However, the academic regulations under which he was first admitted, shall continues to be applicable to him.

9 Award of Class

After a student has satisfied the requirements prescribed for the completion of the program and is eligible for the award of B. Tech. Degree, he shall be placed in one of the following four classes:

The marks obtained in internal evaluation and end semester / I year examination shall be shown separately in the memorandum of marks.

10 Minimum Instruction Days

The minimum instruction days for each semester/I year shall be 90/180 days.

- There shall be no branch transfers after the completion of the admission process.
- There shall be no transfer from one college/stream to another within the Constituent Colleges and Units of Jawaharlal Nehru Technological University Hyderabad.

13 WITHHOLDING OF RESULTS

If the student has not paid the dues, if any, to the university or if any case of indiscipline is pending against him, the result of the student will be withheld and he will not be allowed into the next semester. His degree will be withheld in such cases.

14. TRANSITORY REGULATIONS

- 14.1 Discontinued, detained, or failed candidates are eligible for readmission as and when next offered.
- 14.2 After the revision of the regulations, the students of the previous batches will be given two chances for passing in their failed subjects, one supplementary and the other regular. If the students cannot clear the subjects in the given two chances, they shall be given equivalent subjects as per the revised regulations which they have to pass in order to obtain the required number of credits.
- 14.3 In case of transferred students from other Universities, the credits shall be transferred to JNTUH as per the academic regulations and course structure of the JNTUH.

15. General

- 15.1 Wherever the words "he", "him", "his", occur in the regulations, they include "she", "her", "hers".
- 15.2 The academic regulation should be read as a whole for the purpose of any interpretation.
- 15.3 In case of any doubt or ambiguity in the interpretation of the above rules, the decision of the Vice-Chancellor is final.
- 15.4 The University may change or amend the academic regulations or syllabi at any time and the changes or amendments made shall be applicable to all the students with effect from the dates notified by the University.
- 15.5 The students seeking transfer to colleges affiliated to JNTUH from various other Universities/Institutions, have to pass the failed subjects which are equivalent to the subjects of JNTUH, and also pass the subjects of JNTUH which the candidates have not studied at the earlier Institution on their own without the right to sessional marks. Further, though the students have passed some of the subjects at the earlier institutions, if the same subjects are prescribed in different semesters of JNTUH, the candidates have to study those subjects in JNTUH in spite of the fact that those subjects are repeated.

REVISED ACADEMIC REGULATIONS R15 FOR B. TECH. (LATERAL ENTRY SCHEME)

Applicable for the students admitted into II year B. Tech. (LES) from the Academic Year 2015-16 and onwards

Eligibility for award of B. Tech. Degree (LES)

- I. The LES candidates shall pursue a course of study for not less than three academic years and not more than six academic years.
- II. They shall be permitted to write the examinations for two more years after six academic years of course work.
- The candidate shall register for 168 credits and secure 160 credits from II to IV year B.Tech. Program 2. (LES). The student can avail exemption of two subjects upto 8 credits, that is, one open elective and one elective subject or two elective subjects for the award of B.Tech. degree with compulsory subjects as listed in Table-1.

- The students, who fail to fulfil the requirement for the award of the degree in 8 consecutive academic 3. years (6 years of study + 2 years additionally for appearing exams only) from the year of admission, shall forfeit their seats.
- The attendance regulations of B. Tech. (Regular) shall be applicable to B.Tech. (LES). 4.

Promotion Rule 5

- 5.1 A student shall be promoted from II Year to III year only if he fulfills the academic requirement of 17 credits from one regular and one supplementary examinations of II year I semester irrespective of whether or not the candidate takes the examination, and secures prescribed minimum attendance in Il Year Il Semester.
- 5.2 A student shall be promoted from III year to IV year only if he fulfils the academic requirements of 50 credits from the following examinations, whether the candidate takes the examinations or not, and secures prescribed minimum attendance in III Year II Semester.
 - Two regular and two supplementary examinations of II year I semester.
 - b. Two regular and one supplementary examinations of II year II semester.
 - One regular and one supplementation examination of III year I semester.

Award of Class 6.

After a student has satisfied the requirement prescribed for the completion of the program and is eligible for the award of B. Tech. Degree, he shall be placed in one of the following four classes:

REVISED ACADEMIC REGULATIONS R15 FOR B. PHARM. (REGULAR)

Applicable for the students of B. Pharm. (Regular) from the Academic Year 2015-16 and onwards.

1. Award of B. Pharm. Degree

A student will be declared eligible for award of the B. Pharm. Degree if he fulfils the following academic regulations:

- 1.1 The candidate shall pursue a course of study for not less than four academic years and not more than eight academic years.
- 1.2 After eight academic years of course work, the candidate is permitted to write the examinations for two more years.
- 1.3 The candidate shall register for all the prescribed 224 credits and secure all the 224 credits.
- The students, who fail to fulfil all the academic requirements for the award of the degree within ten academic years from the year of their admission, shall forfeit their seats in B. Pharm. course.

4. <u>Distribution and Weightage of Marks</u>

- 4.1 The performance of a student in each semester or I year shall be evaluated subject-wise for a maximum of 100 marks for a theory and 75 marks for a practical subject. In addition, Seminar and Project Work shall be evaluated for 50 and 100 marks, respectively.
- 4.2 For theory subjects the distribution shall be 25 marks for Internal Evaluation and 75 marks for the End-Examination.
- 4.3 For theory subjects, during a semester there shall be 2 mid-term examinations. Each mid-term examination consists of one objective paper, one essay paper and one assignment. The objective paper and essay paper shall be for 10 marks each with a total duration of 1 hour 20 minutes (20 minutes for objective and 60 minutes for essay paper). The Objective paper is set with 20 bits of multiple choice, fill-in the blanks and matching type of questions for a total of 10 marks.

The essay paper shall contain 4 full questions (one from each unit) out of which, the student has to answer 2 questions, each carrying 5 marks.

While the first mid-term examination shall be conducted on 1 to 2.5 units of the syllabus, the second mid-term examination shall be conducted on 2.5 to 5 units. 5 marks are allocated for Assignments as specified by the subject teacher concerned to the first Assignment should be submitted before the conduct of the first mid-examination, and the second Assignment should be submitted before the conduct of the second mid-examination. The total marks secured by the student in each mid-term examination are evaluated for 25 marks, and the average of the two mid-term examinations shall be taken as the final marks secured by each candidate.

However, in the I year, there shall be 3 mid term examinations (each for 25 marks), along with 3 assignments in a similar pattern as above (1st mid shall be from Unit-I, 2nd mid shall be 2 &3 Units and 3rd mid shall be 4 & 5 Units) and the average marks of the examinations secured (each evaluated for a total of 25 marks) in each subject shall be considered as final marks for the internals/sessionals. If

any candidate is absent from any subject of a mid-term examination, an on-line test will be conducted for him by the university. The details of the Question Paper pattern is as follows:

- The End semesters Examination will be conducted for 75 marks which consists of two parts viz. i).
 Part-A for 25 marks, ii). Part -B for 50 marks.
- Part-A is compulsory question which consists of ten sub-questions. The first five sub-questions are from each unit and carries 2 marks each. The next five sub-questions are one from each unit and carries 3 marks each.
- Part-B consists of five Questions (numbered from 2 to 6) carrying 10 marks each. Each of these
 questions is from one unit and may contain sub-questions. For each question there will be an
 "either" "or" choice (that means there will be two questions from each unit and the student should
 answer any one question)
- 4.4 For practical subjects there shall be a continuous evaluation during a semester for 25 sessional marks and 50 end semester examination marks. Out of the 25 marks for internal evaluation, day-to-day work in the laboratory shall be evaluated for 15 marks and internal examination for practical shall be evaluated for 10 marks conducted by the laboratory teacher concerned. The end semester examination shall be conducted with an external examiner and the laboratory teacher. The external examiner shall be appointed from the clusters of colleges which are decided by the examination branch of the University.
- 4.5 There shall be a seminar presentation in IV Year I Semester. For the seminar, the student shall collect the information on a specialized topic and prepare a technical report, showing his understanding of the topic, and submit it to the department. It shall be evaluated by the Departmental Academic Committee consisting of Head of the Department, Seminar Supervisor and a Senior Faculty Member. The seminar report shall be evaluated for 50 marks. There shall be no external examination for the seminar.
- 4.6 Out of a total of 100 marks for the project work, 25 marks shall be allotted for Internal Evaluation and 75 marks for the End Semester Examination (Viva Voce). The End Semester Examination shall be conducted by a committee consisting of an external examiner, head of the department, supervisor of the project and a senior faculty member of the department. Seminar and project work shall be on the same topic. The evaluation of project work shall be conducted at the end of the IV year. The Internal Evaluation shall be on the basis of two seminars given by each student on the topic of his project.
- 4.7 The Laboratory marks and the sessional marks awarded by the College are subject to scrutiny and scaling by the University wherever necessary. In such cases, the sessional and laboratory marks awarded by the College will be referred to a Committee. The Committee will arrive at a scaling factor and the marks will be scaled as per the scaling factor. The recommendations of the Committee are final and binding. The laboratory records and internal test papers shall be preserved in the respective institutions as per the University norms and produced to the Committees of the University as and when required.
- 4.8 There shall be a Comprehensive Viva-Voce in IV year II semester. The Comprehensive Viva-Voce will be conducted by a Committee consisting of the Head of the Department and two Senior Faculty members of the Department. The Comprehensive Viva-Voce is intended to assess the students' understanding of the subjects that he studied during the B. Pharm. course of study. The Comprehensive Viva-Voce is valued for 100 marks by the Committee. There are no internal marks for the Comprehensive Viva-Voce.

5. Attendance

- 5.1 A student is eligible to write the University examinations only if he acquires a minimum of 75% of attendance in aggregate of all the subjects.
- 5.2 Condonation of shortage of attendance in aggregate up to 10% (65% and above and below 75%) in each semester or I year may be granted by the College Academic Committee.
- 5.3 Shortage of Attendance below 65% in aggregate shall not be condoned.
- 5.4 A student who is short of attendance in a semester / I year may seek re-admission into that semester/I year when offered within 4 weeks from the date of the commencement of class work.
- 5.5 Students whose shortage of attendance is not condoned in any semester/I year, are not eligible to write their end semester examinations of that class and their registration stands cancelled.
- 5.6 A stipulated fee shall be payable towards condonation of shortage of attendance.
- 5.7 A student will be promoted to the next semester if he satisfies the attendance requirement of the present semester/l year, as applicable, including the days of attendance in sports, games, NCC and NSS activities..
- 5.8 If any candidate fulfils the attendance requirement in the present semester or I year, he shall not be eligible for readmission into the same class.

6. Minimum Academic Requirements

The following academic requirements have to be satisfied in addition to the attendance requirements mentioned in item no. 5.

- 6.1 A student is deemed to have satisfied the minimum academic requirements if he has earned the credits allotted to each theory/practical design/drawing subject/project and secures not less than 35% of marks in the end semester exam, and minimum 40% of marks in the sum total of the midterm and end semester exams.
- 6.2 A student will not be promoted from I Year to II Year unless he fulfills the academic requirement of 28 credits out of 56 credits of I year from all the examinations and secures prescribed minimum attendance in I year.
- 6.3 A student shall be promoted from Second Year to Third year only if he fulfills the academic requirement of 50 credits from one regular and one supplementary examinations of I year, and one regular and one supplementary examination of II year I semester irrespective of whether or not the candidate takes the examination, and secures prescribed minimum attendance in II Year II Semester.
- 6.4 A student shall be promoted from third year to fourth year only if he fulfils the academic requirements of total 84 credits from the following examinations, whether the candidate takes the examinations or not, and secures prescribed minimum attendance in III Year II Semester.
 - a. Two regular and two supplementary examinations of I year.
 - b. Two regular and two supplementary examinations of II year I semester.
 - c. Two regular and one supplementary examinations of II year II semester.
 - d. One regular and one supplementation examination of III year I semester.
- 6.5 A student shall put up in the required minimum attendance in all classes and earn all the 224 credits. Marks obtained in all subjects registered for 224 credits shall be considered for the calculation of percentage of marks.
- 6.6 Students who fail to earn 224 credits as indicated in the course structure within ten academic years from the year of their admission shall forfeit their seats in B. Pharm. course and their admission stands cancelled.

7. Course pattern

- 7.1 The entire course of study is for four academic years. I year shall be on yearly pattern and II, III and IV years on semester pattern.
- 7.2 A student, eligible to appear for the end examination in a subject, but absent from it or has failed in the end semester examination, may write the exam in that subject during the period of supplementary exams.
- 7.3 When a student is detained in a semester/year due to shortage of attendance, he may be readmitted when the same semester/year is offered for the next academic year for fulfillment of academic requirements. However, the academic regulations under which he was first admitted, shall continues to be applicable to him.
- 7.4 When a student is detained due to lack of credits, he may be promoted to the next academic year only after acquiring the required academic credits. However, the academic regulations under which he was first admitted, shall continues to be applicable to him.

8. Award of Class

After a student has satisfied the requirements prescribed for the completion of the program and is eligible for the award of B. Pharm. Degree, he shall be placed in one of the following four classes:

The marks obtained in internal evaluation and end semester /I year examinations shall be shown separately in the memorandum of marks.

9. Minimum Instruction Days

The minimum instruction days for each semester/I year shall be 90/180 days.

10. There shall be no branch transfers after the completion of the admission process.

11. There shall be no transfer from one college/stream to another within the Constituent Colleges and Units of Jawaharlal Nehru Technological University Hyderabad.

12. WITHHOLDING OF RESULTS

If the student has not paid the dues, if any, to the university or if any case of indiscipline is pending against him, the result of the student will be withheld and he will not be allowed into the next semester. His degree will be withheld in such cases.

13. TRANSITORY REGULATIONS

13.1 Discontinued, detained, or failed candidates are eligible for re-admission to two earlier or equivalent subjects at a time as and when offered.

13.2 The candidate who fails in any subject will be given two chances to pass the same subject; otherwise,

he has to identify an equivalent subject as per R13 academic regulations.

13.3 After the revision of the regulations, the students of the previous batches will be given two chances for passing in their failed subjects, one supplementary and the other regular. If the students cannot clear the subjects in the given two chances, they shall be given equivalent subjects as per the revised regulations which they have to clear in order to obtain the required number of credits.

13.4 In case of transferred students from other Universities, the credits shall be transferred to JNTUH as per

the academic regulations and course structure of the University.

14. General

14.1 Wherever the words "he", "him", "his", occur in the regulations, they include "she", "her", "hers".

14.2 The academic regulations should be read as a whole for purpose of any interpretation.

14.3 In case of any doubt or ambiguity in the interpretation of the above rules, the decision of the Vice-Chancellor is final.

14.4 The University may change or amend the academic regulations and syllabi at any time and the changes and amendments made shall be applicable to all the students of all classes with effect from the date notified by the University.

14.5 There shall be no transfers of students from one constituent college to another constituent college of

Jawaharlal Nehru Technological University Hyderabad.

The students seeking transfer to colleges affiliated to JNTUH from various other Universities/Institutions have to pass the failed subjects which are equivalent to the subjects of JNTUH, and also pass the subjects of JNTUH which the candidates have not studied at the earlier Institution, on their own without the right to sessional marks. Further, though the students have passed some of the subjects at the earlier institutions, if the same subjects are prescribed in different semesters of JNTUH, the candidates have to study those subjects in JNTUH in spite of the fact that those subjects are repeated.

Applicable for the students admitted into II year B. Pharm. (LES) from the Academic Year 2015-16 and onwards

1. Eligibility for award of B. Pharm. Degree (LES)

- 1.1 The LES candidates shall pursue a course of study for not less than 3 academic years and not more than six academic years.
- 1.2 They shall be permitted to write the examinations for two more years after six academic years of course work.
- 1.3 Register for all 168 credits and Secure all the 168 credits.
- 2. The students have to acquire 168 credits from II to IV year B. Pharm. program (LES) for the award of B. Pharm. degree.
- The students, who fail to fulfil the requirement for the award of the degree in 8 consecutive academic years (6 years of study + 2 years additionally for appearing exams only) from the year of admission, shall forfeit their seat.
- 4. The attendance regulations of B. Pharm. (Regular) shall be applicable to B. Pharm (LES).

5. Promotion Rule

- 5.1 A student shall be promoted from II Year to III year only if he fulfills the academic requirement of 17 credits from one regular and one supplementary examinations of II year I semester irrespective of whether or not the candidate takes the examination, and secures prescribed minimum attendance in II Year II Semester.
- 5.2 A student shall be promoted from III year to IV year only if he fulfils the academic requirements of 50 credits from the following examinations, whether the candidate takes the examinations or not, and secures prescribed minimum attendance in III Year II Semester.
 - Two regular and two supplementary examinations of II year I semester.
 - b. Two regular and one supplementary examinations of II year II semester.
 - c. One regular and one supplementation examination of III year I semester.

6. Award of Class

For the Autonomous Affiliated Colleges also to provide one chance to write the Internal examinations in the failed subjects and/or subjects not studied to the students transferred from other Universities/Institutions to JNTUH Autonomous Affiliated Colleges who are on rolls, as per the clearance (equivalence) letter issued by the University.

Under the circumstances as stated above, the Vice-Chancellor is pleased to approve the above modifications, subject to the ratification by Executive Council.
